## President's Column

### The 2020 National Convention (Part 1)

The 2020 LWV National Convention was a virtual event attended by several members of LWVKA. Delegates summarized the program and their experiences in this first, of a two part report. The second part of the report will be featured in the October Voter.

#### Introductory Sessions

The 2020 National Convention kicked off on Thursday, June 25. Just like many other events of 2020, the LWV National Convention was modified in response to COVID-19. The LWV National Team worked diligently and over a short period of time to make the modifications necessary to be able to continue with many of the events that were originally planned.

Historically, when the National Convention is held in Washington D.C., convention delegates have the opportunity to visit Capitol Hill to meet with their members of congress or congressional staffers to lobby about items that are important to LWV. This year's Lobby Day was held virtually. On Thursday, LWV Convention Delegates and LWV members were encouraged to contact Congress to tell them to restore the vote by passing the *Voting Rights Advancement Act*. The date of the virtual Lobby Day was significant as it was seven years ago to the day that the Supreme Court rolled back provisions of the Voting Rights Act.

The pre-convention session on Thursday opened with welcome remarks from current LWV President, **Chris Carson**. After that, the parliamentarian, **Barbara Rosi**, reviewed the procedures and logistics of the virtual convention since this format was new to all delegates.

The final event of the day was a panel discussion that was moderated by LWV CEO **Virginia Kase**. The panel consisted of three voting rights experts including Washington D.C. Mayor **Muriel Bowser**, **Valerie Jarrett** of *When We All Vote*, Allison Riggs of the *Southern Coalition for Social Justice*, and **Alejandra Castillo** of YWCA. The highly informative panel discussion focused on the topics of expanding the vote and making democracy representative of all. These panelists were excellent participants for this conversation. This panel discussion was streamed via Facebook Live so many others, in addition to the LWV National Convention Delegates could view it.

## LWVUS Update

On August 19 LWVUS, National Urban League and Common Cause filed a lawsuit against the Postmaster General and the United States Postal Service. The lawsuit addresses the recent changes to postal procedures and equipment which present undue burden on the fundamental right to vote, infringes on voters' freedom of speech rights and violates the Administrative Procedures Act (APA).

## Grand Rapids Unit

Our Geographical Unit continues League work during this important election year while making changes to do so safely. We have been rethinking our approach to voter registration and education to ensure we are creating opportunities that are safe for both our volunteers and participants.

On August 27, the GRGU hosted a voter registration event with the *Grand Rapids Young Professionals* at Linc Up. This location was easily accessible for participants and provided the opportunity for them to register to vote using contactless registration by scanning a QR code with their smartphone. The same process could be used to request an absentee ballot, pledge to vote, or access Vote411 for election information.

The GRGU has also partnered with the *Michigan Non-profit Association* for their *Engaging New Voters* project for the 2020 Election. This partnership provides the League with an opportunity for a substantial grant to support their voter registration and education efforts.

Voter education is a critical part of ensuring voters are empowered. We are currently in the process of finalizing a "Voting 101" presentation during two events scheduled for September 14 and October 14. They are being promoted through the *Kent County Essential Needs Task Force*, which works with 130 nonprofit organizations throughout the Greater Grand Rapids Area. The presentation walks participants through the process of registering to vote, understanding the importance of voting, learning how to request an absentee ballot and so much more. It is also an opportunity to ensure that all of their voting questions are answered so they are prepared to vote in November.

### A Note About Absentee Ballots

Clerks will begin mailing out absentee voter ballots on September 24. They will be available for early in-person voting in clerks' offices on that date as well.

A ballot tracking tool on the [Michigan.gov/vote](http://Michigan.gov/vote) site allows voters to check when their clerk receives their absentee voter ballot request, when they mailed out the ballot, and when they received the ballot back from the voter.

*Reminder: Mail your absentee ballot at least two weeks before the November 3 general election and track it.*





