▲ That is DC Emancipation Day? On April 16, 1862 the District of Columbia Compensated Emancipation Act freed over 3,000 individuals bound in labor in the nation's capital. This was eight months before the Emancipation Proclamation freed slaves in the South. The Act offered reimbursement to those who had legally owned slaves and offered the newly freed men and women money to emigrate. This Act was notable also because DC was the only jurisdiction directly governed by Congress.

LWVUS recently shared its 2022 Election Impact report which noted the League reached more than 27 million voters. The report is available at lwv.org.

The LWVUS is in a new phase of transformation which is Framing the Future. All members will receive an invitation in early April to complete a short survey about their League experiences. e pay tribute to **Janet Scarrow**, Life Member of the League who served for 2 terms as LWV-KA's president in the 1970s. Janet impressed League members with her great interest in and knowledge of public affairs, masterful moderation of candidate forums, and the insightful, articulate observations that she backed up with facts. Members appreciated her run for local office, wishing she could have exercised her talents in local government. Members also remember Janet as a good listener and attentive friend.

## Kay Perry shared this story:

I worked with Janet to convince delegates to a LWVMI Convention to support a project to create a biennial report card highlighting government activities that enhanced or diminished citizen access to government. What I remember most about that work was Janet's insistence that we be precise in what we requested and the rationale for the project. Close enough just wasn't good enough! We were successful in convincing the delegates and for a number of years, the League did publish the Citizen's Access to Government Report Card.

### Terry Hluchyj noted:

Janet's diligence and wisdom helped keep us on track and navigate complex, and sometimes thorny, issues regarding localgovernance and election processes. Those studies are the basis of several current League positions.

# We Need You to Take Action

Are you wanting to make a difference in what laws our legislature passes? There is a quick and easy way you can make this happen from the comfort of your own home. Periodically you will receive an email from the President or Co-Presidents of the LWVMI saying "Action Alert" in the subject line. This email means that there is pending state legislation that is important to our League program. So far in 2023 there have been Action Alerts for gun safety laws, electing the President of the USA through a national popular vote not the electoral college and the Elliot-Larson civil rights act.

It only takes a few minutes to respond to an action alert. You will be asked to type in your address and the legislators for your area will automatically pop up. A letter is produced for you that you can preview and sign. Our legislators really do take notice when large numbers of people respond to an issue and LWVMI is 2,600 members strong!

The LWVKA Calhoun County Geo Unit has been most active with working to get gun safety legislation passed in the Michigan House and Senate. Several members (and their grandchildren and friends) have attended rallies at the Capitol. The Unit partnered with the Marshall United Methodist Church for a "Letters and Lemon Bars" letter writing campaign. Thank you to all of those who have taken part in letting legislators know our concern around gun violence.

All of our county clerks have been contacted to assess current needs, with only one precinct, city of Marshall, needing election inspectors at this time. Please sign up if you can help. For the May election there are limited ballot issues. Marshall and Marlee Schools have items on the ballot, as well as two districts that overlap with other counties. The Marshall and Marlee ballot items will be in the Vote 411 digital link.

The Unit is building information for the **National** 

Popular Vote initiative and will be sharing materials in the county as well as sharing forums by other leagues. We also have a chair for the newly formed Money in Politics committee which has been formed by Washtenaw County. We are anxious to learn and share information on these two issues. Educational resources are being shared with Unit members. We are strongly encouraging members to respond to state and national "take action" alerts, building support by large numbers responding.

**Climate Crisis Month** learning opportunities have been presented to the Unit. Our membership committee is posting flyers across the county, providing our mission and contact information.

At this point the Unit is receiving and pursuing nominations for key openings for our board. We are anxious to add new perspectives, skills and energies to our group. Please contact us if you are willing to serve or know others who would be good candidates. We're looking forward to continued leadership growth.


