EVENTS UPDATE



he Voter Services team has contacted all area high schools to offer assistance with the State of Michigan Youth Voter project, presentations or registration events. Lakeview High School is participating with the state again this year, led by their staff and students. Lakeview was an award winner last year. Marshall High School hosted class presentations by the Calhoun County Unit in April. The Voter Services team is planning for the Senior Fair in May and upcoming events this summer.

League members are active on several advocacy drives through the state. Members have trained on and are involved in committees around the National Popular Vote, Money in Politics and the Gun Safety legislation. The Unit partnered with Marshall United Methodist Church for a Lemon Bars and Letter writing event with great participation. Election Update

t is a busy time for election officials and clerks across the state. They have their hands full preparing and executing necessary requirements of Proposal Two.

The following updates are in the works:

 Voter registration forms are getting ready to change again. The state is looking at removing the request to be a permanent AV (absentee voting) list; voters will instead be on a permanent list when the ballot is issued. A new form will be created that allow voters to request either addition or removal from the list.

- The state is working on funding to support the requirement of additional drop boxes, and to reimburse clerks for postage required for return ballots and absentee applications and ballots.
- The state is actively working on creating a ballot tracking site for voter use. Testing is in the works.

It is a monumental undertaking to arrange, plan and work to be in compliance with the new amendment voters passed. THANK YOU to everyone for working those long hours to keep citizens safe and able to vote!
