President's Column

LWVMI Convention Summary

The LWVMI convention was held May 19-21 at Kellogg Conference Center in East Lansing. Convention attendees for the LWVKA were **Barb Dircks**, **Rick Freiman, Aimee Bedard, Sue Rosko, MerriKay Oleen-Burkey, Kayla Boonstra** (summer intern), **Chris Kuthe, Connie Ferguson** (as official parliamentarian for the event) and **Denise Hartsough** (as candidate for co-president of LWVMI.)

The business of the State League was conducted. The budget was passed, PMP for the LWVMI remains \$23, all current positions of the LWVMI were confirmed.

Election of LWVMI officers, directors and nominating committee occurred. Our own **Denise Hartsough** was elected Co-President. **MerriKay Oleen-Burkey** was elected Vice-President of Membership. **Regena Nelson** was elected to the nominating committee. Congratulations and appreciation to all who were elected!

There was a by-laws change approved– Article VI, Section 2 addition: In executing the duties of their office, board members are expected to carry out applicable laws and regulations as well as League bylaws, mission, policies, principles, positions, standards, and procedures. Board Members who do not shall be counseled. If violations persist they may be removed from office by a two-thirds vote of the Board of Directors.

It is recommended that all local Leagues add a similarly worded change to their by-laws to provide a method to remove elected board members who act in inappropriate, unprofessional or harmful ways. We will take this bylaw change up at our next annual meeting in 2024.

A Recommended Concurrence was approved:

The League supports full service public library systems.

- 1. Public libraries support our First Amendment right to intellectual freedom and expression by playing an important role in facilitating free and open access to information.
- 2. Individuals should be trusted to make their own decisions about what they read and believe. Removing and banning books from public libraries is a slippery slope to government censorship and the erosion of our country's commitment to freedom of expression.
- 3. Library staff, operating within the standards of the American Library Association, should make professional decisions about selection, organization, preservation, and dissemination of resources, services and technologies without political interference.

A non-recommended two year study of the "Right to Die" was voted down due to concerns about spreading resources too thin during the 2024 election year.

LWVUS Update Paula Manley

June is Pride Month June 5—World Environment Day June 19—Juneteenth



On May 20th LWVUS celebrated the 30th anniversary of the passage of the National Voter Registration Act (NVRA). The NVRA increased accessibility to the electoral process and reformed voter registration. Also known as the "motor voter bill", it allowed citizens to register to vote at motor vehicle agencies, as well as by mail and through other agencies that serve the public. The League led the campaign for its passage in the 1980s and 1990s with a national grassroots campaign. At the signing of the bill, President Clinton called the League "fighters for freedom".

The LWVUS continues to urge Congress to support the ERA. At the end of April, the Senate voted on a resolution to affirm the validity of the ERA. A bipartisan majority of senators supported it, but a 60-vote threshold was need to overcome a filibuster and failed. Senator Schumer filed a motion to reconsider, which will allow him to bring it up later in this Congress. LWVUS reports that since February, 15,000 supporters have urged Congress to support ERA. If you have not yet done so, contact your Congressional delegates to urge support. *©*


LWVKA Book Discussion Group

We all felt that this was a worthwhile and rejuvenating convention and we were grateful for attending. Here is a collection of comments from those who attended.

Sue Rosko: Thank you for the great opportunity to attend the LWVMI convention! As a member of the LWVMI Credentials Committee charged with helping to count the delegates prior to any plenary votes and through attending sessions and events, I was able to meet and network with many members from around the state. That all was a gift! What an opportunity the convention was to share resources and ideas. The speakers were great, inspiring and calling us to continued action. The Engagement in



Minority Communities and the Censorship workshops provided much insight into the importance of understanding and working with DEI to provide voting opportunities and advocacy for rights for all. Valuable ideas for reaching other populations were shared.

Kayla Boonstra: Throughout the convention each speaker provided relevant and thoughtful dialogue while engaging the audience, as well as, a plethora of valuable information. I am excited to take my new found wisdom gained at the convention and apply it to our League's work.

Aimee Bedard: My most important take away from

convention was that the terms we use to advocate and discuss an issue are important. Firearm safety is the term we should be using vs the term gun safety/violence which only highlights one aspect of this issue. A graph was shown that highlighted how automobile deaths decreased over time as safety measures were put in place and research



was funded to address issues. Firearm deaths have not been addressed in a similar manner.

Rick Freiman: I am glad I went to the convention. The leaders, presenters, and resources provided were very motivational. I attended the "Leaders Bootcamp" and "Creating a Campus Unit" Workshops. I was also impressed by the dedication of the Michigan leaders. They all seemed to be passionate and knowledgeable, and were volunteers just like us in LWVKA, and I believe they are trying hard to be a resource for us. Finally, it was a great networking experience to be able to mingle with so many professional and talented people from all areas of the State. I met people from the U.P. that can help me get closer to legislators up there for Climate advocacy.

Barb Dircks: Censorship and the demand to remove books from the shelves is becoming an issue for many local leagues and libraries. This issue was one presentation at the State Convention as local leagues work to counter these initiatives and continue the mission of educating voters. Participants, in groups, shared perspectives that raised the issues of parent groups, political party agendas and community Library Board power struggles as a few of the underlying grievance issues. It was expected that Censorship will continue to be an issue as we move into the 2024 election cycle.

Preparations are being made in anticipation of Proposal II requirements. The state legislature is hoping to resolve many of the adjustments and funding issues before the July recess. The Governor signed bill SB 259 on May 1st, 2023, which will allow absentee ballots filed by residents that are overseas or military ballots, to be counted if received up to six days after the election. They just have to be postmarked by the election date.

Thanks to the passage of the proposition, voters will have extended time and additional options. These and others were mentioned during a State Convention presentation: additional ballot boxes, exploring early vote counting needs and ballot tracking were others. There is a network of people working tirelessly to figure this all out and make it happen! THANK YOU!

In other Voter Services areas, Lakeview Schools again participated in the High School initiative through the state. They earned awards last year. This year their staff and students are using the past and new materials from the SOS office to continue the registration and education program. In April the students held a registration event for the school. **Lori Closson-Kline** and **Linda Smoot** (Vote 411) presented five Marshall High School with Voter Education. Job well done in all areas by Calhoun's Voter Services team.

Volunteers will now be needed for our Juneteenth events in Albion and Battle Creek, both on Saturday, June 17. Washington Height Family Fair and Pride Fest in Battle Creek have requested tables on Saturday, July 22. Please watch your emails for scheduled times and volunteer as we continue to build community relationships.

Clerk Engagement

Susan Stuart recognized each of the counties clerks with the Secretary of State's proclamation. Invited to attend a special meeting of the County Clerk, the president was able to commend and offer League support again to the each of the clerks. Kristi Dougan from the Board of provided updates on implementation of Proposal 2 and where clerks had concerns in implementation. When nine days of early voting is instituted, among other things the clerks will need support with poll workers. Members are encouraged to become poll workers and to encourage others to do the same, including responsible students. Clerks are beginning to explore possibilities for instituting the nine days of early voting. The Election representative and Calhoun County Clerk expressed appreciation for the League.

For our Annual Meeting Calhoun County's Clerk was invited to speak, sharing the inner workings of the election process. The integrity, multiple checks and balances was shared. Later in the meeting our Clerk Kemberly Hinkley was honored with our inaugural Champion of Democracy Award. We appreciate her diligence, professionalism, calmness in tough situations, commitment to democracy and the truth and her kind spirit. Kimberly has worked in great relationship with out Unit, readily welcoming us and providing necessary information for our League projects such as 411.

Advocacy

Having attended the Challenging Borders International Conference at Albion College and the LWVMI Convention the continued need for understanding, dispelling mis- and dis- information, and taking action continues to be emphasized.

End Gun Violence: Chair Susan Stuart has an active committee. She thanked members for helping to get this important initial legislation passed. They continue to be active in advocacy and share updates on events and actions needed. On May 5 the Calhoun Unit was invited by a Battle Creek Central High School staff person to host a Voter Registration/Information table at an Anti-Gun Violence rally organized by their students. With the loss of two members of the Senior Class and a loss in each of the last 4 senior classes, the students are motivated to take action against Gun Violence. Lori and Sue served at the table, sharing our End Gun Violence information, registering students and urging students to vote. Several speakers-mayor, school police officer, family, state representative and student leaders—shared passionate testimony and call to action. The coverage can be found on the Calhoun County LWVKA Facebook page, in the Battle Creek Enquirer, and on WWMT. Members are encouraged to attend the Kalamazoo event on June 5 and to continue to support state and national legislation.

Money in Politics: Lisa Reed is attending the LWVMI study committee meetings led by LWV Washtenaw. She will be reporting back to the Unit.

National Popular Vote: Karen Weideman and Sue Rosko are trained with the LWVMI materials. Further assistance in sharing information would be appreciated. Nay 9th, 2023 Denise Hartsough and Chris Kuthe attended a cultural exchange at Global Ties Kalamazoo, 225 W Walnut St, Suite 209. In attendance were six women from Bangladesh and three interpreters. The women were members of parliament, heads of political parties, a bank officer and the Assistant Director of the Bangladesh Telecommunication Regulatory Commission. Many were lawyers. They were interested in learning more about the LWV. We described our history and current work. They said they had no organizations in their country that focused on the voters and admired our work. We found out that one-third of Bangladesh's elected officials must be women, based on the quota system they have in place. They have much better maternal leave support-from birth to 3 years old and free college. It was an amazing experience and we both felt privileged to be included.

Barbara Huber. long time LWVKA member, passed away on April 9th. She was an active League member at both the local and state level. Barbara served as LWVKA President. She was on the Nominating Committee from 1999-2001. She delivered Voter Guides and assisted with League finances as Treasurer and donor.

Barbara served on the LWVMI Board as National Resources Director in 1991-92. From 1995-97 she was on the Legislative Advisory Committee as Air Quality Chair. She chaired the LWVMI Nominating Committee in 1985-87.

Barbara had a strong interest in local governance, co-chairing the LWVKA Local Governance Study with Janet Scarrow. She was on the Texas Township Planning Commission. Barbara was instrumental in arranging a candidate forum which LWVKA hosted in July, 2012. Eleven candidates vying for various township positions on the August primary ballot presented their views and responded to questions before an audience of 125.

Paula Manley remembers first meeting Barbara in 1977 and hearing about the canoe trip LWVKA members had taken down the Kalamazoo River to study the pollution. Her life long interest in the environment was evidenced by her work on LWVMI board and committees and in her Texas Township community. She brought the recycling station and famer's market to the Texas Township Hall. Barbara was also a talented weaver and a member of the Weaver's Guild. We celebrate her dedication to the League and her service to her community.
