# LWVUS Update Paula Manley

Anniversary of 19th Amendment Ratification

August 26—Women's Equality Day

President Lyndon Johnson signed the Voting Rights Act of 1965 on August 6, 1965. The Act outlawed the discriminatory voting practices which had been adopted in states after the Civil War such as the literacy test requirement. In 2013 the Supreme Court ruled in Shelby County v. Holder that it is unconstitutional to use the coverage formula in Section 4(b) of the Voting Rights Act to determine which jurisdictions are subject to preclearance requirement of Section 5. LWVUS reports that in 2023, 322 bills restricting voting access have been introduced in State Legislatures nationwide. The Freedom to Vote Act has been introduced in the House and Senate to ensure all eligible voters have access and the freedom to vote.

On June 4, 1919, Congress proposed the 19th Amendment. Tennessee was the 36th State to ratify the Amendment on August 18, 1920, which met the required ratification of ¾ of the States. Secretary of State Bainbridge Colby certified the ratification of the 19th Amendment on August 26, 1920, which granted women the right to vote. We know that the struggle did not end on August 26, 1920, as various groups of women such as Native Americans and Black women could not exercise that right.

# **Voting Rights Enacted**

The State Legislature passed 8 election bills implementing the PTV 2022 ballot proposal. The bills go next to the Governor for her signature and then take effect 90 days after the end of the legislative session.

The bills provide:

- enhanced tracking system for absentee ballots and applications
- at least 9 days of early voting; pre-processing and early tabulation of absentee ballots 8 days before an election
- signature matching and curing process; prepaid postage for absentee ballots and applications
- more types of identification for voter identification purposes

- penalties for disclosing early voting results
- drop boxes for every 15,000 voters, one accessible drop box and video monitoring for certain drop boxes
- permanent mail ballot list, so voters sign one application to receive an absentee ballot for every future election
- increase the size of Election Day precincts from 2,999 to 5,000 active registered voters

Already passed was a measure allowing 6 days after the election to tabulate overseas ballots and electronic voting for military members.

# National Popular Vote Compact

The National Popular Vote bills, HB 4156 and HB 4440, are on second reading in the Michigan House of Representatives. SB 126 and SB 295 are in the Senate Elections & Ethics Committee. LWVMI is advocating for their passage.

Minnesota recently passed National Popular Vote legislation. That means that states with 205 electoral votes have committed to the compact. A total of 270 electoral votes are needed to implement the compact. Adoption of the compact in Michigan would add 15 electoral votes.

# Recycling Your Plastic Bags

Peijer has launched several initiatives over the years with regard to its commitment to sustainable practices and the reduction of plastic waste in the environment, including the January opening of its first small-format store without single-use plastic bags: Woodward Corner Market. Although, the use of reusable bags are currently restricted due to the coronavirus pandemic, with the exceptions of customers using the company's Shop & Scan technology and at self-checkouts.

Since 2014, each Meijer store has also placed collection bins inside its front entrance vestibules for customers to deposit clean, dry plastic bags and films, including single-use, bread, dry cleaning, produce and water softener bags. And in 2019, Meijer began adding a How2Recycle label on its own brand packaging to better help customers understand how to dispose of the materials, and the retailer set a goal that Meijer brand packaging will be made from 100% reusable, recyclable or compostable materials by 2025.

"Lessening our impact on the environment through increased recycling efforts is an issue that is important to us and our customers, and one that we are working diligently to address," said Erik Petrovskis, director of environmental compliance and sustainability for Meijer. "I look forward to reviewing the innovative solutions that will stem from this collaboration. "

# Global Ties Cultural Exchange- India

was organized by Global Ties of Kalamazoo. The women from India were professors, lawyers and housewives. Our discussion, through interpreters, encompassed the topics of discrimination and violence

They were interested to learn about the work our League accomplishes and they hope to create something to help defend their democracy.

# **Advocacy**

Advocacy co-directors for the Unit are monitoring needs and LWV action statements. The following chairs/committees are currently working:

**End Gun Violence:** Members attended the Wear Orange rally in Kalamazoo. Partner information was helpful. Committee chair **Susan Stuart** is attending meetings of the SMART committee and other non-partisan groups in SW Michigan, as well as finding any groups specific to Calhoun County that are being formed. We continue to share important information on social media. The SMART posters will be shared and cards are available at the Unit's Voter Services tables.

**Money in Politics:** The Unit is represented by Lisa Reed on the LWVMI study committee meetings led by LWV Washtenaw. Information and materials will be shared.

**National Popular Vote:** On behalf of the Unit, a letter to support the NPV was sent to specified legislators. This was done at the request of our LWVMI Advocacy Chair, Judy Karandjeff. Members were asked to follow the "Take Action" link on the LWVMI website and to share it with others.

**ERA and Disclose Act:** Members are asked to go to lwv.org to use the "Take Action" link to encourage legislators to continue working to support reinstating the ERA into the constitution and to take action on dark money (Disclose Act).

**Legislative Interviews:** No action has been taken yet.

New directors **Judy Cieslak** and **Susan Anderson** are researching Calhoun County to see what environmental groups are currently active in the county. They will be making plans for information/action for our Unit for the 2023-24 year.


