Recent litigation includes the following:

LWV of South Carolina filed an amicus brief in a racial gerrymandering case Alexander v. SC NAACP. The US Supreme Court will hear the case this fall.

LWV of North Dakota filed a motion seeking to intervene on behalf of voters and LWVND members to defend against a challenge to the state mail-in voting process.

LWVUS has launched #WID23 which urges support for Women's Equality addressing Voting Rights, Constitutional Equality with the Equal Rights Amendment and Reproductive Freedom. Further information is available at lwv.org. /WID23.

### **Legislative Watch**

lection bills signed by the Governor on July 18, 2023 that take effect 90 days after the end of the legislative session:

Enhanced tracking system for absentee ballots and applications

At least nine days of early voting and pre-processing and the early tabulation of absentee ballots eight days before the election if involving 5000+ people

Signature matching and curing process and prepaid postage for absentee ballots and applications

More types of identification allowed for voter identification purposes

Penalties for disclosing early voting results

Drop boxes required for every 15,000 voters with one accessible; video monitoring for all

Permanent mail ballot list established so voters sign one application to receive an absentee ballot for every future election

Increase size of Election Day precincts from 2,999 active registered voters to 5,000

Budget bill HB 4437 allocates funds to implement Promote the Vote 2022 with immediate effect.

National Popular Vote bills are on second reading in the House of Representatives, and in the Senate Elections & Ethics Committee. LWVMI advocates for their passage!

Voter transportation bill would remove the prohibition against transporting voters that is unique to Michigan. A lawsuit against the prohibition was filed in Oakland Circuit Court, as well.



# News From the Kalamazoo County Clerk's Office


### **Updated Automatic Voter Registration**

Starting in August and going forward, SOS is integrating automatic voter registration (AVR) into additional driver's license transactions. The process for clerks will not change, but voter registration status updates will occur earlier and with more frequency for some driver's license holders.

Currently, automatic voter registration is included in mail transactions for driver's license renewals and changes of address. In addition to these transactions, AVR will now be included in mail transactions when a driver's license holder advances to Graduated Driver's License (GDL) Level 2 or 3, or when a GDL holder progresses to operator's license status. As with other mail AVR transactions, voters will receive a notice that they will be automatically registered to vote unless they opt out. This notice will provide the individual with 30 days from the date the letter was issued to opt out of AVR. The customer can opt out by mailing the letter to the Bureau of Elections (BOE) or through online services. If the customer does not opt out within the 30-day timeframe they will be registered to vote.

### **Address Confidentiality Program Act**

In December 2020, Governor Whitmer signed the Address Confidentiality Program Act, Public Act 301 of 2020, MCL 780.851 et seq. The Address Confidentiality Program (ACP) was created to provide certain protections for victims of domestic violence, sexual assault, stalking, human trafficking, or those who fear that disclosure of their physical address will increase the risk of harm. Information on how the program works and how to enroll are available on the Address Confidentiality Program website. The program is scheduled to launch at the end of August. # DropBox Procurement (Public Act 85 of 2023/House Bill 4697)

The Michigan Constitution and Public Act 85 of 2023 requires all jurisdictions to have at least one state-funded drop box for every 15,000 registered voters in the jurisdiction. BOE is required to facilitate the procurement and distribution of these drop boxes.

Every jurisdiction is entitled to at least one new state-funded drop box, even if one was provided in 2020. Clerks must ensure drop boxes are distributed equitably throughout the city or township.

Sheriff Steve Hinckley supplied us with additional gun locks as they also support gun safety. The Calhoun

Unit will host a table at the September 16 Festival of the Forks in Albion and is working to participate in events at Kellogg Community College and Albion College for outreach to students. Two members served as observers for the Calhoun County Canvassing board as they certified the August election votes. Once again the board was meticulous and professional in ensuring that the election was secure and accurate. Thank you to all of our members who served throughout the month.

Emphasis this League year for our Unit will be on assisting our county clerks in implementing Proposal 2, educating the public on the importance of voting and their new options, and recruiting additional poll workers. In addition the Unit will host "Quick Bites" quarterly gatherings to share information, get to know each other better through a less formal setting, and increase member involvement/leadership. We are hoping to expand into environmental issues, will continue gun safety education, and will strongly advocate with state and national LWV on voting rights and equality issues. We are active on the Money in Politics committee and have connected with non-partisan partners in voter services, clerk engagement and combatting mis- dis- information. Our participation/ representation on LWVMI meetings provides information, connection and the power of unity in reaching our mutual LWV mission and goals. A statement by the Women's Equality panel stressed the need for civics education beginning at a young age. They've come after the Black community, the LGBQ community, and into Women's rights. it—be about it!" The elder on the panel finished with her wisdom, "If you know your history, you know why you vote!" Our mission and vision have never been more relevant!




