The John R. Lewis Voter Registration Act HR 14 has been reintroduced in Congress. This bill will fully restore and modernize the Voting Rights Act. League members are asked to contact their Representatives to urge passage to protect voting rights.

Governor Whitmer announced her priorities for the fall legislative session:

- 1. Protect Reproductive Health by passing the Reproductive Health Act, which LWVMI supports.
- 2. Lower the Cost of Health Care by codifying the cost-saving measures of the Patient Protection & Affordable Care Act in Michigan law, which L WVMI supports.
- 3. Lower the Cost of Prescription Drugs, LWVMI has not reviewed this legislation yet.
- 4. Enact a 100% Clean Energy Standard, Improve Energy Efficiency, Empower the MI Public Service Commission and Streamline Permitting. LWVMI is working with MI Energy Council and MI Energy and MI Jobs as the bills go through the legislative process.
- 5. Establish Paid Family and Medical Leave, which LWVMI supports.
- 6. Shore Up Election Security, which LWVMI supports.

Other Updates:

LWVMI joined the Michigan Health Is Health Coalition to require health insurers in Michigan to provide coverage for medically necessary treatment of a mental health or substance abuse disorder.

LWVMI supports the Fair Chance Access to Housing

Act to ensure access to housing for those with convictions. No legislative hearing has taken place yet.

LWVMI continues to advocate for the National Popular Vote bills, which are on second reading in the House and in the Senate Elections & Ethics Committee.

Veterans Services Proposal

The LWVKA Board has endorsed the ballot proposal to fund Kalamazoo County Veterans Services Office which appears on the November 7th ballot. This proposal will levy .1 mil to support the Kalamazoo County Veterans Service Office. The millage seeks to give the Veterans Services Office long-term stability by ensuring funding for the next decade.

The Board considered two relevant League Positions in their decision to support the ballot proposal. The LWVUS Position on Meeting Basic Human Needs states in part: "Persons who are unable to work, whose earnings are inadequate, or for whom jobs are not available have the right to an income or services sufficient to meet their basic needs for food, shelter and access to health care." The LWVKA Position on Providing Government Services in Kalamazoo County discusses areas to be assessed in judging a services delivery system which includes: "Funding mechanisms (e.g., adequate, equitable, stable)".

his month has been a very successful month of connecting with and beginning/expanding partnerships with other non-partisan organizations. Kellogg Community College has expressed their respect for LWV and have now joined with us at each VP level and within various departments. Albion College's Gerald Ford Institute also held a registration table and gathered the Calhoun County League Information to share with students. A coalition of non-partisan groups has formed under the SW Michigan region of ACLU. Our Unit has taken the lead in sharing county information with the group and has arranged for a group meeting with the County Clerk. Our partnership with clerks remains strong. We've shared an article on Promote the Vote, Registration and the Poll worker survey with the news media and social media. This and links to the survey and other information was shared with all of our GOTV partners as well. The colleges were given the Student Voter Summit link/flyer and encouraged to send staff and students.

Registration/Information tables were hosted by members at the Festival of the Forks in Albion, Kellogg Community College's Bruin Blast, and on September 30 at the Big Read in Albion. A big thank you to the volunteers, including new members, who stepped forward to allow us to make these happen. Each event was very well received and many new contacts were made. Information was tailored at each to meet the demographics of the community. Registering voters or sharing the access to online registration, voter

rights and Proposal 2 were shared at each event. SMART gun safety was shared at Festival of the Forks, Calhoun County Clerk's survey to encourage registration as poll workers was shared at the Bruin Blast, and banned books are to be shared at the Big Read.

On September 26 the Events Committee hosted their first Quick Bites. Quick Bites is an hour long, simple gathering to get to know one another and to share a piece of information on one of the Unit's projects. In September our Voter Services director will present the LWVMI Promote the Vote material. The community is invited. We're looking forward to getting to know each other and conversing about what our Calhoun LWVKA is doing.

"All You Need is Love: Holding Biodiversity Close in a Changing World"




