LWVUS Update

WVUS reports that over two million voters accessed Vote411.org during the recent election cycle. This is the most ever for a non-federal election cycle. Vote411.org covered 20,000 races and 46,000 candidates.

Following the news of the recent passing of former First Lady Rosalynn Carter, the LWVUS issued this statement:

"The League of Women Voters offers our deepest condolences to the Carter family, and we are forever grateful for Rosalynn Carter's dedication to public service. Let us pay tribute to her memory and may each of us aspire to leave a lasting legacy."

LWVUS issued the following statement regarding the recent appeals Court ruling on the Voting Rights Act:

"The League of Women Voters urges the Supreme Court to overturn the appeals court's misguided decision undermining the Voting Rights Act (VRA), uphold recent precedent with Section 2 of the VRA, and protect the right for Black Americans."

n November. 9 the Calhoun Geographical Unit held its Quick Bites (Meet & Greet and information sharing) at Albion College's Ludington Center in Albion. The public, including Albion College, was invited as Lori Closson-Kline presented the LWVMI information on implementation of Proposal 2. It was encouraging to have in attendance new potential members, Albion area women who are concerned about voting rights and our democracy. In November Lori, the Unit's Voter Services director also held a virtual presentation of the LWVMI Proposal 2 information which was recorded and shared with Calhoun County's GOTV partners and is available on Facebook and YouTube.

The Unit's Environmental Committee is studying environmental and social justice issues related to the challenges to the public with the decreased transportation services in Battle Creek and countywide. Possibilities for our Unit to respond after the study are being explored. We are also moving forward with a potential graphics design intern from Kellogg Community College.

We will be looking for continued involvement and expanded leadership. Again, possibilities only become actions with the help of many. This remains vital as we step into 2024. 
